20 September - Patient involvement, websites and communication- what does good look like?

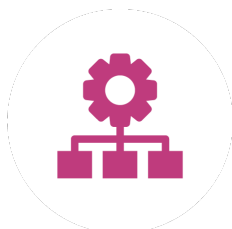
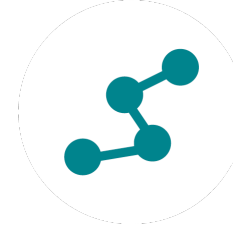
18 October - The Environment – examples of model pathways and how services adapt? Key considerations

Clinical Pathways

- At present a key focus for our workstream is the Colon Capsule Endoscopy national pilot following our successful application to Bevan Commission Planned Care Innovation Programme for funding for the pilot in 2022/23. As a Bevan Exemplar, this pilot will have the best chance of success and we are supporting the 4 participating health boards to start up their pilots in the next few months. 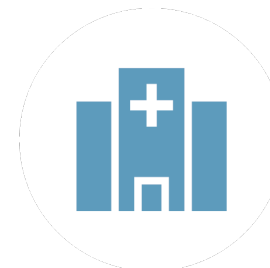


Demand and Capacity

- Supporting regional groups for implementation of recovery plan
- Tracking of actual data against model projections has been added to scorecard and released to health boards
- Briefing paper being produced to summarise findings on productivity data

Facilities and Infrastructure

- Programme is continuing to offer support to Health Boards on their progress in compliance against the JAG accreditation standards. This includes monthly drop-in sessions focused on specific standards, with support from the National JAG team.
- All-Wales decontamination forum taking place June 2022 - annual decontamination audits are continuing to be undertaken by Shared Services to advise Health Board on the standard of their decontamination facilities. The programme is supporting Health Boards by escalating key risk areas.
- The programme is working in collaboration with the British Society of Gastroenterologists (BSG) to develop a 'Green Endoscopy' checklist to be circulated to Health Board teams to improve the sustainability & efficiency of endoscopy practice.



Informatics

- Welsh Clinical Portal - Following on from the successful Welsh Clinical Portal (WCP) updates at Hywel Dda and Swansea Bay University Health Boards and Powys ERS Go-Live, planning work is progressing with Powys Teaching Health Board, to make available Endoscopy and Bronchoscopy results in the WCP.

Workforce Planning

Building upon the success of our first NEP workforce event held in May, we are

working closely with Health Boards across Wales in order to support local workforce planning. Developing local plans in a standardised way, using the All-Wales template and toolkit (as developed by HEIW) will support regional and national endoscopy workforce strategy and planning. The NEP aim to complete this programme of work by the end of the summer 2022.

Productivity

The Programme has been busy meeting with Health Boards to understand the local processes in place to measure the productivity & efficiency of their endoscopy services. The NEP has recommended five data items that services should look to measure:

1. **Overall/individual utilisation of lists**
2. **Booked versus achieved points for each list**
3. **Late start and early finish times audit**
4. **Room turnaround audit**
5. **Did not attend (DNA) and cancellation rates.**

It is clear that there is variability across Wales with regards to the monitoring of these measures, however it is great to note that there is an appetite from Health Board teams to improve local processes.

The Programme will continue to work with services to identify any support that can be offered going forward.
