As reported in the last edition, as of 1st April 2023 the NHS Wales Health Collaborative and several other organisations became part of the NHS Wales Executive. A national support function, providing strong leadership and strategic direction – enabling, supporting, and directing NHS Wales to transform clinical services in line with national priorities and standards.

On 1st October 2023, the National Imaging Programme joined the Strategic Programme for Planned Care which covers Planned Care Cancer and Diagnostics. Gweithlu ac Addysg

Cyflawniadau Allweddol Ch2 2023/24

- Mae'r Grŵp Trawsnewid y Gweithlu Delweddu ac Addysg (IWETG) wedi cwblhau adolygiad o'r blaenoriaethau a'r prosiectau i sicrhau eu bod yn dal i fod yn gydnaws â'r Strategaeth Trawsnewid ac Adfer Diagnosteg ar gyfer Cymru 2023-2025.
- Gwnaed cynnydd ardderchog mewn prosiect sydd â'r nod o roi sylw i argymhellion yn ymwneud â'r Gweithlu Cefnogi Radioleg a geir yn y Strategaeth ar gyfer Datblygu Model Gweithlu Radioleg i Gymru. Mae'r Gweithgor Gweithwyr Cefnogi Delweddu (ISWG) wedi gwneud adolygiad cynhwysfawr o rolau Gweithwyr Cefnogi Clinigol Radioleg (RCSWs) ym Mand 2 a Band 3, gyda'r nod o sicrhau bod y rolau hyn yn gweithredu mor effeithiol â phosibl a'u bod yn gydnaws ag anghenion gwasanaethau Radioleg i'r dyfodol. Cafodd swydd-ddisgrifiadau ar gyfer Cymru gyfan eu creu er mwyn eu safoni ac i helpu â datblygiad staff, caiff y camau nesaf eu cymryd i sicrhau y glynir wrth yr holl ofynion llywodraethu.

Workforce and Education

Q2 2023/24 Key Achievements

- The Imaging Workforce and Education Transformation Group (IWETG) have completed a review of priorities and projects to ensure these remain aligned to the Diagnostics Recovery and Transformation Strategy for Wales 2023-2025.
- Rapid progress has been achieved within a project aiming to address recommendations relating to the Radiology Support Workforce contained within the Strategy for Developing a Radiology Workforce Model for Wales. The Imaging Support Worker Group (ISWG) have comprehensively reviewed the roles of Radiology Clinical Support Workers (RCSWs) at Band 2 and Band 3, aiming to ensure these roles are optimised and aligned to the future needs within Radiology services. All-Wales job descriptions to facilitate standardisation and support staff development have been created, and next steps are being undertaken to ensure adherence to all governance requirements.
- Evaluation of the accredited education currently available for Band 2 and Band 3 RCSWs has been completed, and we thank all of those who took the time to provide their

- Mae'r gwaith ar ddogfen Canllawiau Codio ESR ddrafft bron â dod i ben, gyda'r nod o sicrhau cysondeb pan gofnodir y Gweithlu Delweddu Diagnostig ar systemau ESR. Bydd hyn yn ei gwneud hi'n haws creu darlun mwy cywir o'r gweithlu hwn a bydd o gymorth wrth gynllunio'r gweithlu i'r dyfodol.
- Mae Harriet Ryland, Rheolwr Rhaglenni ar gyfer y Ffrwd Waith Gweithlu ac Addysg, wedi symud ymlaen i gyfle newydd a chyffrous. feedback and experiences. A paper detailing these findings was well received, with IWETG endorsing further work to establish the potential opportunities for optimisation.

- Creation of a document providing a visual overview of the role of RCSWs is underway, aiming to highlight the varied and specialist nature of these roles and how these differ from those within other areas of Health Care Support.
- The ISWG is about to commence reviewing the roles of the Band 4 support workforce within Radiology, ensuring these are aligned to the future requirements of Diagnostic Imaging and with equitable access to training and education available across Wales.
- Work is nearing completion of a draft ESR Coding Guidance document, aiming to ensure consistency in recoding the Diagnostic Imaging Workforce on ESR systems. This will facilitate accurate visualisation of this workforce and assist with future workforce planning.
- Harriet Ryland, Programme Manager for the Workforce and Education workstream, has moved on to a new and exciting opportunity. We send her our thanks for her hard work and wish her all the very best for the future. We have successfully recruited a new Programme Manager and we are looking forward to welcoming them to the team in the coming months.

Quality, Safety and User Experience

Q1 2023/24 Key Achievements

- The All-Wales Imaging Quality Forum (AWIQF) met on 5th July and 6th September 2023.
- Updated Terms of Reference for the Forum were approved at meeting on 5th July.
- RCR/ScoR presented their case for Endorsement on 6th September 2023.
- The Business Case for QSI staffing and accreditation was completed and taken to NIPSB on 15th June 2023.
- The AWIQF will undertake an options appraisal as to the next steps with regard to accreditation of imaging services in Wales following a presentation by the United Kingdom Accreditation Service (UKAS) at the next meeting in early October.
- Workstream has continued to scope AI within Radiology in Wales, collaborating with Welsh Government and Public Health Wales. This remains in its infancy and will initially investigate the governance around any implementation of AI as well as quality checking the services it will provide and compliment as well as the risks.
- Ultrasound Guidance update document has been shared with Imaging Essential Services Group (IESG). Has now been forwarded to Welsh Scientific Advisory Committee (WSAC) for next steps.
- The first All-Wales MRI Quality Group meeting took

Phase 3 – Implementation and Establishment of Review Function

- Review Panel standard operating procedure and timeline finalised.
- First formal Review Panel was held on Tuesday 26th September 2023 at River House. The panel was very well attended with 15 members in person at River House and a further 2 joining via MS Teams. All Health Boards and Trusts were represented and participated pragmatically, contributing to a successful outcome.
- Terms of Reference for the Review Panel formally approved.
- The scoring process worked well on the day, with positive feedback from members at the end of the session.
- The desired outcome from the panel was achieved, with a national prioritised list of equipment agreed for capital replacement. This will be presented to Welsh Government, National Diagnostics Board and other key stakeholders in the coming weeks.
- Decision made to move the formal review process from quarterly to bi-annually, documentation and timelines will be updated and communicated accordingly.
